NEW RECREATION CENTRE:

Chiefs Get A Sneak Peek Inside Hazelton's New Recreation Centre



This summer one of Hazelton's most exciting community projects - a state of the art, year-round recreation facility adjacent to the old ice rink - is set to open with an NHL-sized ice rink, a basketball court, a fitness centre, banquet facilities and a host of other amenities.

The grand opening is set for September, but on April 12, 14 Hereditary Chiefs, four Huwilp Government staff and a handful of others and were treated to a tour of the new facility, which will include programs and services for all ages and a variety of sporting and cultural interests.

"This facility is a place of belonging and hope for all people. Because of this facility our children will be stronger, safer, and ready for the future. We did this together and we should be proud," says Hereditary Chief Brian Williams.

Excitement was visible as Chiefs toured through the gymnasium, the ice rink and bleachers, and team change rooms. Finally, participants were treated to an up-close encounter with the facility's new Zamboni, with some of the more adventurous Chiefs even taking a turn to sit proudly in the driver's seat.

The recreation centre has been made possible by the financial contributions and collaboration of many people and organizations in the Upper Skeena region and beyond including private donors, federal and provincial governments, Bulkley Valley Credit Union, Royal Bank of Canada, the Vancouver Canucks, Gitxsan Government Commission and the Treaty Society.



Once open, it will become a huge part of the social, economic and physical wellness of the whole region as a host to tournaments, public skating, weddings, birthdays, conferences, workshops and gatherings.

The Huwilp Government representatives in attendance expressed their appreciation to Peter Newbery and Carol Huynh for their vision and hard work in making this happen for Hazelton and its people.

The facility will open sometime this summer, with a grand opening event to celebrate to be held in the fall.

GITXSAN HISTORICAL TIMELINE

1867

Canada constitution ac created

1932 Five chiefs charged

1982

Gitxsan and Wetseweten Chiefs sue BC and Canada for ownership and jurisdiction over our laxyip

1986

Dropped the colonial system (band councils) and went fully into the hereditary system

1996BC left the treaty

2000

Trilateral negotiations begin again between Gitxsan, Canada and BC

2009-2010

Gitxsan Development Corporation created to build the local economy from the ground up

1846

First contact between colonialists and Gitxsan people

1925

Canada outlawed the feast (Liligit)

1972

Gitxsan Carrier Tribal Council established and run by 8 elected chiefs (but jurisdiction was only reserves)

1984

Trial starts (Created Chiefs Advisory Team (CAT) with 3 members from each clan and a Litigation Team). Advisory team organized witnesses and organized testimony as well as raised funds for litigation.

1994

Gitxsan Treaty Society is formed from the CAT team members

1997

The landmark Supreme Court of Canada decision (The Delgamuukw Decision) was handed down Dec. 11, 1997. Since then, other First Nations in BC, across Canada and around the world are using the Delgamuukw decision to seek justice on aboriginal title through the courts and through negotiations.

2003

Interim forest agreement reached, resulting in forest licensing.

2018

Present Gitxsan Huwilp Government structure established by Simogyet (Hereditary Chiefs), organized into downriver chiefs and upriver chiefs. First objective is to address the salmon crisis with an overarching goal to protect and preserve the Gitxsan way of life.

Crisis Management Meeting Update: April/May 2019

Initiated and led by Gitxsan Simgiigyat, the Crisis Management Team is an advisory group to the Gitxsan Huwilp Government. The crisis at-hand is the issue of protecting the fisheries tenure along the Skeena.

The Ayook dictates the Anaat boundaries for each Wilp. According to our law, one Wilp cannot enter another Wilp's Anaat to hunt or fish without permission.



However, the province and the federal government provide access to outsiders through various permits through the permitting process, which is trespassing. The Crisis team will address issues like

how to enforce the fishing ban and deal with access and trespass on our territory.

Every month the Crisis Management Team meets and has invited the Province and Canada to participate in learning about the Gitxsan laws and jurisdiction and coming together to work on a solution. The Crisis Management Team is set out to bring together everyone's intelligence, perspectives, and influence to figure out how to proceed with a shared objective for the 2020 season.

What is the primary issue?

Trespass over the Gitxsan's Annat (fishing sites) by non-native permit holders . The Gitxsan people have laws that have existed for 1000's of years that dictate by who can, and when, fishing holes can be accessed and permission is required (even if you are Gitxsan) by the hereditary chief whose family owns the fishing sites. Some of our fishing sites have become inaccessible due to government infrastructure such as railways. We have a fish crisis problem—environmental changes, habitat destructions by forestry, access and low stock counts.

Proposed Interim Solution

We will require further collaboration and enforcement commitment from the Government and BC Province to support the Gitxsan hereditary chiefs' decision to prohibit all recreational and sport fishing in 2019. This announcement is a step to building awareness on the fish tenure and jurisdiction that exists within the Gitxsan territory and creating a deeper understanding from our stakeholders like the Canadian Gov-

"In our traditions, we usually prepare fish to share amongst our families and our feasts, we were never told how and when we could do this on our own fishing sites. We were taught by our ancestors that we only take what we need and to never play with our fish as there will be retribution for that." –Robin Alexander

ernment and the Province of BC and the general public.

Actions

The Gitsxan Hereditary Chief's issued another press release to the media detailing the closure on April 30, 2019 which was picked up by local media and tourism organizations like CFNR, CFTK TV and Terrace Standard.

Additional Outcomes & Collaboration

On May 10 the Gitxsan Huwilp Government has invited representatives from BC and Canada to visit a Gitxsan Fish Camp to learn more about the Gitxsan culture and the Gitxsan laws that



have existed related to fishing sites. This initiative is to help Canada and BC understand and respect the fish jurisdiction that already exists amongst the Gitxsan and will invite decision makers to make changes to their permitting processes to help better create a collaborative approach to our Fish Crisis Issue at hand.

Future Collaboration & Meetings

Meetings have been confirmed to undertake presentations by the Gitxsan Hereditary Chiefs, BC and Canada to talk and their jurisdictions and an action plan to address a more collaborative approach between all three governments. A discussion that was proposed was to create an administrative tribunal or committee to adjudicate on the Fish Crisis Issue.

Further dialogue is required, and the Gitxsan

Hereditary Chiefs are hopeful that the recent fish closure announcement applies weight on stakeholders to move on policies for enforcement and collaboration.

"All persons holding recreational fishing permits and/or fish guiding licenses are no longer allowed to trespass in Gitxsan territory. People need to know that when they fish here, they are trespassing in controlled territory," says Brian Williams, Chair of Gigeenix (Up River Chiefs).

Since September 2017, in a historic


An advisory committee called 'Crisis Team' has been created by the Chiefs to focus on discussing public access to fisheries tenure/Anaat for the year 2020. The committee's mandate also includes an advisory role with stakeholders like BC and Canada and collaboration with other First Nations dealing with the salmon crisis, as part of the Skeena Nations Fish Forum Protocol.

The Crisis team is collaborating with the government to create a future process where all recreational fishers require permission from individual Chiefs to fish on the river. While the ban marks the beginning of an ambitious journey, the process fully respects the Daxgyet of the Simgiigyet and adheres to the tenets of the traditional system (Ayook, Adaakw and Lilliget).

"Our fish are in crisis and this is an ongoing situation with a track record that has been going downhill. We have to do something. The next step we talk about is to find a path to turn this around and banning recreational and sports fishers from fishing our traditional territory is a step in the right direction," says Art Wilson (Wiimoulglxsw), Gitxsan Hereditary Chief.

A communication platform that includes a website, newsletters and live streaming of meetings has been created to promote transparency around the decisions and actions of Huwilp Government. A full list of participating Chiefs is posted. While 38 Chiefs are currently participating, and the goal is to reflect all of the traditional Gitxsan Anaat.
